- Separation of Mail-in Ballots and drop box envelopes and separation of ballots by district.
- Whether Maryland uses BePro, Total Votes, or No link software.
- Whether the public can request more than five minutes of speaking time.
- Whether there were any plans to stop the use of drops boxes and whether there is surveillance on the drop boxes.

Ms. McCord requested the questions be put in writing and emailed to the Board. She stated the Board will respond to the questions in writing. She further indicated the question on Mail-in Ballots was previously submitted to the Board and addressed. The question concerning software was a question for the State Board of Elections. Finally, Ms. McCord stated the General Assembly is responsible for the law concerning the use of drop boxes.

Ms. Taylor discussed the case for a Special Election that is pending before the Supreme Court. Oral arguments are scheduled for April 4, 2023. If the office is legally directed to hold a Special Election, it would encompass District F and District F voters only. Ms. Taylor demonstrated where District F is located on the Election map and stated that it contains approximately 34,600 voters. Ms. Taylor said there is a possibility that the race could be added to the presidential ballot in 2024. She stated the difficulty in opening all polling locations due to schools possibly being in session. The office has begun to scout private locations, such as local churches, and a local recreation center.

At this point, Ms. Taylor presented the Smartsheet Timeline for the Possible District F Special Election. She explained that the timeline included the possibility of drop boxes, early voting, and included both a primary and general election. Ms. Taylor stated that the Timeline is currently based on a May 1st start date.

Ms. McCord inquired about filing dates and deadlines. Mr. Price asked who made that decision and Mr. Taylor said it would be made by the County Executive. Ms. McCord asked about drop boxes and Ms. Taylor believes that two drop boxes would suffice.

In response to a question from Ms. McCord about Early Voting, Ms. Taylor said the County would make the decision on Early Voting. She also confirmed that there were no local races on the presidential ballot and the State would provide the ballot. Ms. McCord questioned whether Ms. Taylor had spoken with other LBEs that may have held special elections. Ms. Taylor said the County dictates how they want the election to be held. Ms. McCord asked Mr. Young concerning the legal authority and Mr. Young confirmed it would be the County's decision on the procedures for the Special Election.

Ms. McCord asked about the need for Election Judges with less polling places. Ms. Taylor expressed her support for Vote Centers and thought they would be best for voters. She believes 6-8 Vote Centers with large rooms would be sufficient. Ms. McCord asked about advertising information to the voters. Ms. Taylor said the County would be responsible for any advertising. Mr. Dykes asked if the information would be posted on the website and Ms. Taylor answered in the affirmative. Ms. McCord asked about overseas voters. Ms. Taylor explained that UACAVA voters' considerations and deadlines are built into the timeline.

Ms. Taylor explained the ability of the Smartsheet Timeline to forecast additional timelines with various starting dates based on the formulas that have been built into the Smartsheet.

HARFORD COUNTY BOARD OF ELECTIONS **ELECTION OFFICE REPORT April 26, 2023**

Administration:

- Our remaining budget for FY23 is very tight due to having two elections in one budget cycle. Only critical items needed for our day-to-day operations are being purchased.
- We had our FY24 budget work session with the County Council on April 19th.
- The Harford County Board of Elections will be receiving more grant funding. The Fiscal Year 2023 Homeland Security Grant Program has earmarked some of the funding for enhancing election security. This will be coming to us in two parts. The State Homeland Security Program (SHSP) funding provides 3% of the county total to be allocated for enhancing election security. The Urban Area Security Initiative (UASI) funding provides additional funding to the Baltimore area, which includes Harford County. The deadline to apply for these funds is April 24, 2023.

Staff Updates:

Danielle Tinsley is our newest state employee. All open pins positions have been filled.

Election Operations

- We are preparing for the Havre de Grace Election on May 2, 2023.
- Justin and Nate have been working on the precinct refinement.

Election Judges:

- The training of the Havre De Grace Municipal Election Judges was conducted on April 24, 2023.
- Two employees from the Judge department have been distributing recruitment flyers throughout the county these past couple of weeks.
- The return team checklist has been updated for the 2024 election cycle.
- We had a strategizing /planning meeting in reference to HB1200 (election judge pay).
- Meet and greet for judges are ongoing.
- We are in the process of creating and completing new election judge training documents.
- We are continuing to review/update files, forms, and Smartsheets in preparation for 2024.


Legislation

These are the election bills that have been signed into law by Gov. Moore:

- HB0410 Elections Polling Place Plan, Prohibited Acts, and 2024 Primary Election Date: This bill had a few amendments, but passed and includes expanding the public process for polling place changes, shifts polling place plan approval to the state board, further defines and restricts voter intimidation, and moves the date of the 2024 Presidential Primary to May 14th.
- **HB1200 Elections Election Judges Minimum Compensation**: Establishes a statewide minimum payrate of \$250 for election judges. This now includes an additional \$100 per day worked pay increase for returning judges on top of the new minimum pay of \$250, which will be 50/50 cost split with the state.
- HB0535/SB0379 Election Law Ballot Issuance, Processing, and Reporting Procedures and 2024 Primary Date: Allows LBEs to begin canvassing mail-in ballots up to eight days before the first day of early voting, or receive a waiver if canvassing early is not warranted and clarifies how a voter may "cure" an unsigned, timely received mail-in ballot. This bill also moved the 2024 Presidential Primary date to May 14th.
- HB0509/SB0287 State Board of Elections Municipal Elections Publication of Results on Website: Requires that our municipal elections have their results posted on the state website.

LEGAL AUTHORITY

MD Election Law Code Ann. §2-303. Precincts.

- (a) In general. (1) Subject to paragraphs (2) and (3) of this subsection, as it deems it expedient for the convenience of voters, a local board may:
 - (i) Create and alter the boundaries for precincts in the county;
 - (ii) Designate the location for polling places in any election district, ward, or precinct in the county; and
 - (iii) Combine or abolish precincts.

MD Election Law Code Ann. §10-101. In general.

- (a) Designation of polling places In general. (1) Each local board shall designate a polling place that meets the requirements of this subsection for each precinct in the county as established by the local board in accordance with Title 2 of this article.
 - (2) Each polling place shall:
 - (i) provide an environment that is suitable to the proper conduct of an election;
 - (ii) be located as conveniently as practicable for the majority of registered voters assigned to that polling place;
 - (iii) except as authorized in paragraph (4) of this subsection, be in a public building;
 - (iv) be in the precinct that it serves unless no suitable location for a polling place can be found within that precinct, in which case the board may establish the polling place in an adjacent precinct; and
 - (v) whenever practicable, be selected and arranged to avoid architectural and other barriers that impede access or voting by elderly and physically disabled voters.

COMAR 33.15.01.01 - Maps and Descriptions.

- A. Board to Prepare. Each local board shall prepare, or arrange for the preparation of, and make available to the public maps and descriptions that delineate all wards, precincts, and districts that are wholly or partly within its area.
- B. Required Clarity. Each map and description shall provide a delineation of boundaries that is:
 - (1) Clear and concise; and
 - (2) Easily understandable by members of the general public.

COMAR 33.15.02.01 – Scope.

- A. This chapter applies whenever a local board:
 - (1) Creates a new precinct; or
 - (2) Changes precinct boundaries.
- B. For a special election, a local board may combine polling places established for regularly scheduled elections.

COMAR 33.15.02.02 - Precinct To Lie Wholly within District.

A precinct may not be created, and the boundaries of a precinct may not be changed, so as to cross any district boundary.

Precinct Reduction Project

COMAR 33.15.02.03 - Resolution Required.

- A. In General. A local board may create a new precinct or change precinct boundaries only by adoption of a written resolution.
- B. Contents. The resolution under §A of this regulation shall:
 - (1) State the purpose of the change;
 - (2) Contain a written description of all precinct boundaries; and
 - (3) Be accompanied by a map of the area involved.
- C. Filing with State Board. Within 5 days after a resolution is adopted, the election director shall notify the State Administrator in writing of the new precinct or changed precinct boundaries.

OBJECTIVES

- 1. To comply with MD Election Law and corresponding regulations (election districts, precincts, polling places, & maps).
- 2. To enhance the voter experience through efficiency and convenience (room size, location, parking, ease of access, reduce wait times, and maintain social distancing, if necessary).
- 3. Minimize travel distance for relocated voters as best as possible.
- 4. Maximize use of public facilities security, reliability, and access.
- 5. Minimum disruption to historically disenfranchised areas.
- 6. Efficient use of resources election judge recruitment and retention, EDSS, equipment & staff.
- 7. Reduce ballot styles (Election Day and Early Voting) prevent disenfranchising voters.
- 8. Improve speed of election night reporting.
- 9. Fiscal responsibility reduce private location use, judge/labor cost, materials, and delivery.
- 10. Additional equipment to each polling location/increase efficiency of voting process and more surplus available, if needed.

BENEFITS

- 64 Precincts, down 8 from current 72
- 51 Polling places, down 9 from current 60
- Eliminates up to 24 ballot styles
- Eliminates the need for roughly 113 judges
- Saves \$1000 on facility rentals & ~24,000 on judge pay
- EDSS will each cover less polling locations, decrease response time
- Reduced costs in paying mileage to EDSS staff




2022 HARFORD COUNTY ELECTION MAP

(BEFORE REFINEMENT)




2023 PROPOSED PRECINCT REFINEMENT
